4. Chair's Report

This past year in CALA was characterized by great efforts from the Board of Directors, as well as strong support from the CALA staff team, to navigate a new era of success for the organization. Central to this was defining the desired profile of a new CEO, then recruiting a leader that could work closely with the Board and staff, drive service excellence, and set new directions for CALA.

The CALA Board was pleased to appoint Kevin McKinley as the new President and CEO in August 2022. Kevin brings national and international experience to CALA having led Canadian industry and regulatory associations in the last number of years, and previously leading the International Organization for Standardization (ISO) in Geneva, Switzerland as the Deputy and Acting Secretary-General of the organization for a total of 14 years. Kevin has also served on the Board of Directors of the Global Reporting Initiative (GRI) and has co-founded a start-up organization to help assess the ESG performance of online platforms.

With this new leadership in place, and with CALA's return to in-person work and assessments in 2022, the organization is well-positioned to build excellence for its clients, develop new services, and secure new accreditation markets that require credibility and trust.

6. Treasurer's Report 2022 Results

The Finance Committee is comprised of three Directors and Senior management

The goal of the committee is to assist the Board in fulfilling their oversight responsibilities by reviewing financial information, reporting processes, and assessing financial risk

REVENUES:

- Our main revenue streams include accreditation and annual accreditation maintenance fees, membership fees and the Training Program.
- CALA saw a successful year in many respects with regards to Accreditation and Training.
- As budgeted for 2022, training revenues were lower than prior year.
- Through 2022, CALA was able to return to on-site assessments.

PROGRAM EXPENSES:

- Accreditation expenses were significantly higher due to CALA's ability to return to providing on-site assessments.
- Training expenses were lower than prior year, as expected.

SALARIES & BENEFITS, are lower than budget and prior year actual due to staff vacancies throughout the year

The **GENERAL ADMINISTRATIVE** expenses are lower than what was budgeted but higher than the previous year.
